Starting at 6:00 pm on Monday, May 11 the Lakes Region Planning Commission will convene a public exchange with the NH Legislature's Groundwater Commission on **What role should your community have in regulating large groundwater withdrawals?** The meeting will be held in the conference room at the Moultonborough Public Safety Building. To better engage the public, the NH Legislature's Groundwater Commission will ask attendees to respond to a number of questions and topics related to the local and state regulation of groundwater, and the criteria used by the state to make regulatory decisions. The NH Legislature's Groundwater Commission is conducting regional public meetings to complete its work prior to reporting results to the legislature later this year. Given the abundance of water resources in the Lakes Region, this meeting is of special significance and importance to local communities. Anyone with an interest in groundwater resources is invited to attend this timely 'listening' session, and to encourage others to do so.

Prior to the exchange on groundwater, LRPC Commissioners will be asked to take action on recommendations for the 2009 Lakes Region Transportation Improvement Program, and the LRPC's proposed FY 2010 budget.
