Dear LRPC Commissioners, Town Administrators/City Managers, Selectboards/City Councils, Planning Boards, and Interested Parties: On Monday, March 28, 2016 at the Minot Sleeper Library, 35 Pleasant Street, Bristol, NH the Lakes Region Planning Commission will hold its regular Commissioner meeting to discuss Lakes Region Transportation initiatives and the Fixing America's Surface Transportation Act or "FAST Act" recently passed by Congress.

First, LRPC staff will provide some examples of topics being discussed by the Commission's Transportation Advisory Committee (TAC).

Then Mr. Leigh Levine, Planning and Development Manager for the Federal Highway Administration in the New Hampshire Division Office will provide an overview of the New FAST Act which provides nearly \$200 million/year to the State of New Hampshire for transportation improvements.

Finally, we will be joined by Commissioner Victoria Sheehan who was sworn in as the Commissioner of the New Hampshire Department of Transportation on October 19, 2015. Commissioner Sheehan oversees a \$650 million state agency with over 1,600 employees. Commissioner Sheehan is originally from Ireland, and has a Master's Degree in Structural Engineering and Architecture from the University of Edinburgh. In her free time, she also serves as the Chair of the Board of Directors for Camp Wanakee in Meredith NH.
