On Monday, October 23, 2017 at the Squam Lakes Association, the Lakes Region Planning Commission will hold its regular commission meeting.

Our agenda will include a presentation by Michele L. Tremblay, Principal, nature resource communications. She provides organizational development, policy, planning, and training services to federal, state, and local agencies and nonprofit and grassroots groups throughout the Northeast US and Canada from her office in Boscawen. With a strong commitment to volunteerism, she has been a representative to the Upper Merrimack River Local Advisory Committee since 1990 and seventeen years as a member and chair of the Boscawen Conservation Commission. She is President of the New Hampshire Rivers Council. Since 1994, she has served as Program Director for the Upper Merrimack Monitoring Program. She is the governor-appointed conservation representative to the state's Rivers Management Advisory Committee (chair). A New Hampshire native, Michele has served the region and state in a variety of land, planning, river, and lake conservation groups and commissions. She is active in legislative issues and led the effort to pass of a bill that granted shoreland protection to several rivers in New Hampshire. Michele was named the Catch of the Year in 1996, River Conservationist of the Year in 1998, a River Network River Hero in 2003, and the Helen Award for Volunteerism in 2006.

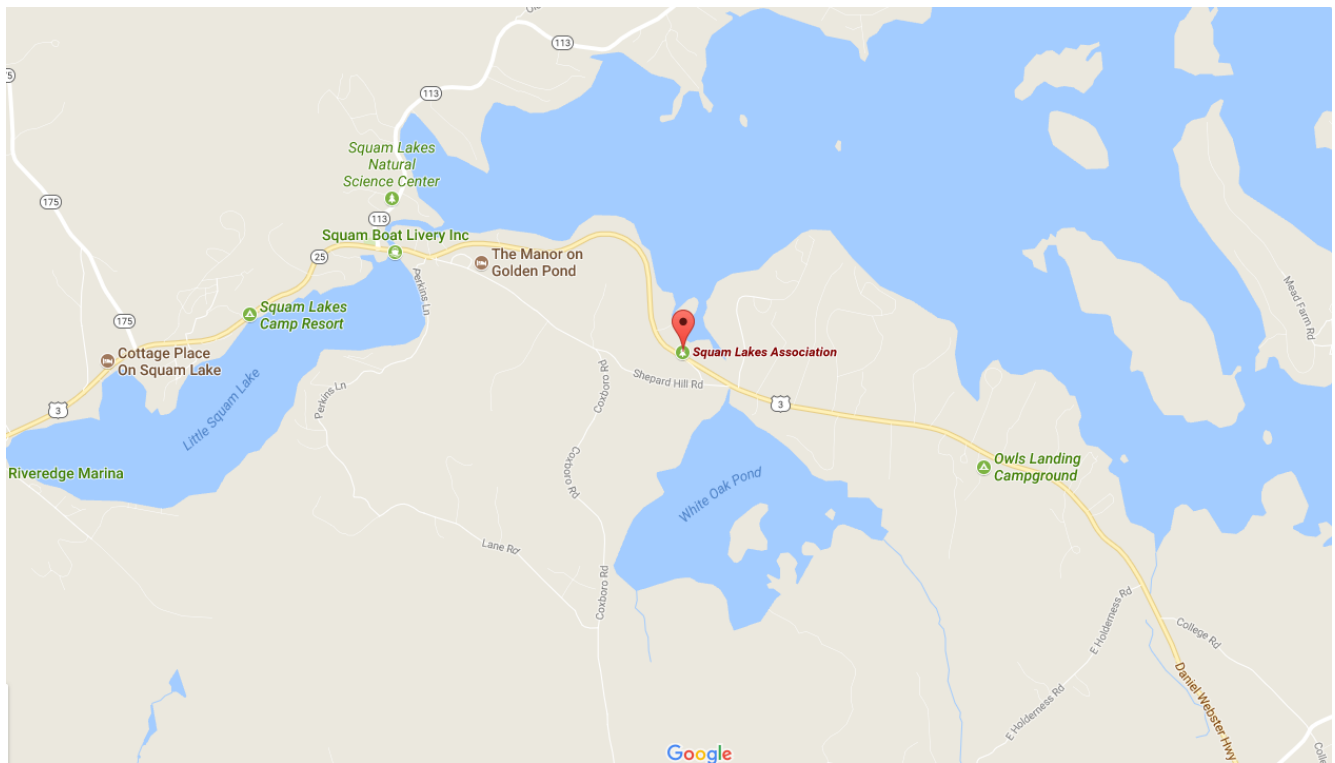
