NH Ten Year Transportation Improvement Plan

The Governor's Advisory Commission on Intermodal Transportation (GACIT) will hold 20 public hearings across New Hampshire to review and receive input on the update of the state's Ten Year Transportation Improvement Plan (TYP) (2021-2030). The purpose of these public hearings is to receive comments/testimony on transportation projects and priorities included in the draft [2021-2030 TYP](#) as recommended by the New Hampshire Department of Transportation to GACIT.

The Hearings are hosted by the Executive Councilors for each of the five council districts. Communities in the Lakes Region are located in two of the five council Districts
