Dear LRPC Commissioners, Legislators, and Interested Parties:

On Monday, January 25 the Lakes Region Planning Commission will convene a meeting featuring two diverse topics. The first will be a presentation on the state's current efforts to coordinate transit planning statewide, and the implications for the Lakes Region. The state already has a State Coordinating Council which hopes to oversee a number of regional coordinating councils. The Coordinating Council effort has been led by the NH Department of Health and Human Services, and the NH Department of Transportation. Being the center of the state, the Lakes Region will be attached to a number of proposed regional coordinating councils. This is an excellent opportunity to learn more about how the state foresees providing access to the those with the greatest transit needs.

Following the transit presentation, an overview of the Lake Winnepesaukee Watershed Management Plan (LWWMP) will be given. The LWWMP is a collaborative effort of the LRPC, Lake Winnepesaukee Watershed Association, the North Country Resource and Conservation District Council, Plymouth State University, BCCD and the University of New Hampshire. With partial funding from the NH Department of Environmental Services and the National Oceanic and Atmospheric Administration, the LWWMP was launched last year using a sub-watershed approach. The presentation will highlight the Plan's grass roots beginning, and then focus on current activities, including the state's efforts to provide communities with a water quality threshold for phosphorus.
